Commissioning and de-commissioning of vehicles 3 Carry out vehicle installs. 4 The Manufacture of bespoke projects for MFRS departments. 5. The service and Maintenance of operational ladders. 6. The collection and delivery of fire vehicles or ancillary equipment, including the collection and delivery of spare parts. 7. To be responsible for all documentation connected with the post (job card completion etc.). 8. To bring to the attention of management any defects that would or could cause damage to the equipment or that may result in or have the potential to cause accidents. 9. To maintain a clean and tidy work area and ensure that general workshop housekeeping is adhered to. 10. To assist management, as required, by moving over to other sections, to assist in minor repairs, servicing, inspection or modification of other Fire Service and partner's equipment. 11. To undertake any other duties deemed suitable by the Authority commensurate with the grade.


